ARTICLES OF AGREEMENT OF FIRST BAPTIST CHURCH OF FARMINGTON, MISSOURI

KNOW ALL MEN BY THESE PRESENT: That we, the undersigned for the purpose of forming a corporation under the laws of Missouri, relating to benevolent associations under Chapter 352, Missouri Revised Statutes for 1969, in comnection with others, have entered into the following agreement:

First: The name of the association shall be First Baptist Church of Farmington, Missouri.

Second: Its location shall be in Farmington, St. Francois County, Missouri

Third: Its duration shall be perpetual.

Fourth: This association is not formed for pecuniary profit in any form, but the purpose is to be a dynamic spiritual organism empowered by the Holy Spirit to share Christ with as many people as possible in our church, community and throughout the world.

To be a worshipping fellowship, experiencing an awareness of God, recognizing his person, and responding in obedience to His Leadership.

To experience an increasingly meaningful fellowship with God and fellow believers.

To help people experience a growing knowledge of God and man.

To be a church that ministers unselfishly to persons in the community and world in Jesus name.

To be a church whose purpose is to be Christ like in our daily living by emphasizing total commitment of life, personality, and possessions to the Lordship of Christ.

Fifth: Membership in this corporation shall be those persons whose names are presently affixed on the rolls of the church, and such persons as may be from time to time elected to the membership in such manner as may be provided for in the By-Laws of the association.

Sixth: The officers of the corporation shall be a president, vice-president, Secretary, and treasurer who shall be elected and hold office in a manner prescribed in the By-Laws of the corporation.

Seventh: The business of the corporation shall be controlled and managed by a Board of Directors, the number, qualifications, and manner of election of whom shall be as prescribed in the By-Laws of the corporation.

#### CONSTITUTION

### PREAMBLE

We declare and establish this constitution to preserve and secure the principles of our faith, and to govern the body in an orderly manner. This constitution will preserve the liberties of each individual church member and the freedom of action of this body in its relation to other churches.

### I. NAME

This body shall be known as the FIRST BAPTIST CHURCH OF FARMINGTON, located at 210 North "A" Street, Farmington, Missouri 63640.

### II. OBJECTIVES

To be a dynamic organism empowered by the Holy Spirit to share Christ with as many people as possible in our church, community, and throughout the world.

To be a worshiping fellowship, experiencing an awareness of God, recognizing his person, and responding in obedience to his leadership.

To experience an increasingly meaningful fellowship with God and fellow believers.

To help people experience a growing knowledge of God and man.

To be a church that ministers unselfishly to persons in the community and world in Jesus' name.

To be a church whose purpose is to be Christlike in our daily living by emphasizing total commitment of life, personality, and possessions to the Lordship of Christ.

### III. STATEMENT OF FAITH

The Holy Bible is the inspired word of God and is the basis for any statement of faith. The church subscribes to the doctrinal statement of "The Baptist Faith and Message" as adopted by the Southern Baptist Convention in 1963. We band ourselves together as a body of baptized believers in Jesus Christ personally committed to sharing the good news of salvation to lost mankind. The ordinances of the church are baptism and the Lord's Supper.

#### IV. RELATIONSHIPS

The government of this church is vested in the body of believers who compose it. It is subject to the control of no other ecclesiastical body, but it recognizes and sustains the obligations of mutual counsel and cooperation which are common among Baptist churches. Insofar as is practical, this church will cooperate with and support the association and state convention affiliated with the Southern Baptist Convention.

### V. CHURCH COVENANT

Having been led, as we believe, by the Spirit of God, to receive the Lord Jesus Christ as our Saviour and Lord, and on the profession of our faith, having been baptized in the name of the Father, and of the Son, and of the Holy Spirit, we do now, in the presence of God, and this assembly, most solemnly and joyfully enter into covenant with one another as one body in Christ.

We engage therefore, by the aid of the Holy Spirit to walk together in Christian love; to strive for the advancement of this church, in knowledge, holiness, and comfort; to promote its prosperity and spirituality; to sustain its worship, ordinances, discipline, and doctrines; to contribute cheerfully and regularly to the support of the ministry, the expenses of the church, and the relief of the poor, and the spread of the gospel through all nations.

We also engage to maintain family and secret devotions; to religiously educate our children; to seek the salvation of our kindred and acquaintances; to walk circumspectly in the world; to be just in our dealings, faithful in our engagements, and exemplary in our deportment; to avoid tattling, backbiting, and excessive anger; to abstain from the sale of and use of intoxicating drinks as a beverage; to be zealous in our efforts to advance the kingdom of our Saviour.

We further engage to watch over one another in brotherly love; to remember one another in prayer; to aid one another in sickness and distress; to cultivate Christian sympathy in feeling and Christian courtesy in speech; to be slow to take offence, but always ready for reconciliation and mindful of the rules of our Saviour to secure it without delay.

We moreover engage that when we remove from this place we will, as soon as possible, unite with some other church where we can carry out the spirit of this covenant and the principles of God's Word.

### Von do hide and Labour and I. MEMBERSHIP

Section 1. General

This is a servereign and democratic Baptist church under the leadership of Jesus Christ. The membership retains unto itself the exclusive right of self-government in all phases of the spiritual and temporal life of this church.

The memgership reserves the exclusive right to determine who shall be members of this church and the conditions of such membership.

Section 2. Candidacy

Any person may offer himself or herself as a candidate for membership in this church. All such candidates shall be presented to the church at any regular church service for membership in any of the following ways:

- (1) By profession of faith and for baptism according to the policies of this church.
- (2) By promise of a letter of recommendation from another Baptist church of like faith and order, being received under the watchful care of the church pending receipt of the letter of recommendation.
- (3) By restoration upon a statement of prior conversion experience and baptism in a Baptist church of like faith and order when no letter is obtainable.

Should there be any dissent as to any candidate, such dissent shall be referred to the pastor and the deacons for investigation and the making of a recommendation to the church within thirty (30) days. A simple majority vote of those church members present and voting shall be required to elect such candidates to membership.

Section 3. New Member Orientation

New church members will be expected to participate in the church's new member orientation plan.

Section 4. Voting Rights of Members

Every member of the church is entitled to vote at all elections and on all questions submitted to the church during business meeting, provided the member is present.

Section 5. Termination of Membership

Membership shall be terminated in the following ways:
(1) death, (2) dismission to another Baptist church, (3) exclusion by action of this church, (4) personal request or by affiliation with another faith.

### Section 6. Discipline

- (1) It shall be the basic purpose of the First Baptist Church to emphasize to its members that every reasonable measure will be taken to assist any troubled member. The pastor, other members of the church staff, and deacons are available for counsel and guidance. Redemption rather than punishment should be the guideline which governs the attitude of one member toward another.
- (2) Should some serious condition exist which would cause a member to become a liability to the general welfare of the church, every reasonable measure will be taken by the pastor and by the deacons to resolve the problem. All such proceedings shall be pervaded by a spirit of Christian kindness and forbearance. But, finding that the welfare of the church will best be served by the exclusion of the member, the church may take this action by a two-thirds vote of the members present at a special meeting called for this purpose; and the church may proceed to declare the offender to be no longer in the membership of the church.
- (3) Persons whose membership has been terminated for any condition which has made it necessary for the church to exclude them may upon their request be restored to membership by a vote of the church upon evidence of their repentance and reformation.

### II. CHURCH OFFICERS

All church officers must be members of the church. The officers of this church shall be as follows:

### Section 1. Pastor

The pastor is responsible for leading the church to function as a New Testament church. The pastor will lead the congregation, the organizations, and the church staff to perform their tasks.

The pastor is leader of pastoral ministries in a church. As such he works with the deacons and church staff to: (1) lead the church in performing its tasks, (2) lead the church to engage in a fellowship of worship, witness, education, ministry, and application, (3) proclaim the gospel to believers and unbelievers, and (4) care for the church's members and other persons in the community.

A pastor shall be chosen and called by the church whenever a vacancy occurs. His election shall take place at a meeting called for that purpose of which at least one week's public notice has been given.

A Pastor's Selection Committee shall be authorized to seek out a suitable pastor, and its recommendation will constitute a nomination. Any member has the privilege of making other nominations according to the policy established by the church. The committee shall bring to the consideration of the church only one man at a time. Election shall be by ballot, an affirmative vote of three-fourths of those present being necessary for a choice. The pastor, thus elected, shall serve until the relationship is terminated by

his request or the church's request. He shall preside at meetings of the church and, if so designated, may serve as moderator in all business meetings. (See Section 4). The pastor shall give at least two weeks notice at the time of resignation before terminating his responsibilities as pastor.

### Section 2. Church Staff

This church shall call or employ such staff members as the church shall need. A job description shall be written by the Personnel Committee and approved by the church when the need for staff members is determined. Vocational staff members other than the pastor shall be recommended to the church by the Personnel Committee and employed by church action. At least two weeks notice at the time of resignation should be given.

The secretaries shall likewise be recommended to the church by the Personnel Committee and employed by church action. Custodians shall be employed on recommendation of the (church property and space committee) trustees.

### Section 3. Deacons

- (1) There shall be one deacon for approximately every fifteen church families.
  - (a) Deacon Selection Committee

This committee shall consist of 5 members who shall be appointed by the moderator at the regular business meeting in June. The committee shall provide an opportunity for each member of the church to suggest in writing the name equal in number to the deacons to be elected that year. The committee shall then tabulate this information and use it to assist them in making nomination. One man shall be nominated for each vacancy to be filled The committee shall interview and ascertain the qualifications of all nominees and shall make its report at the regular business meeting in July. At the next regular business meeting in August the church shall act on the Deacon Nominating Committee report. The deacons elected shall take office on October 1st.

- (b) The deacons shall serve on a rotation basis. Each year the term of office of one-third of the number of deacons shall expire, and election shall shall be held to fill the vacancies. In case of death or removal or incapacity to serve, the church may elect a deacon to fill the unexpired term. After serving a term of three years, a deacon shall be eligible for reelection only after a lapse of at least one year. There is no obligation to constitute as an active deacon a person who comes to the church from another church where he has served as a deacon.
- (2)(a) In accordance with the meaning of the work and practice of the New Testament, deacons are to be servants of the church. The pastoral ministrie tasks; proclaim the gospel to believers and unbelievers; care for church members and other persons in the community; lead the church to engage in a fellowship of worship, witness, education, ministry, and application; and lead the church in performing its tasks; and will be encouraged to participate in special training opportunities provided by the church.
  - (b) Immediately after deacons have been elected by the church, they will meet to organize, selecting their officers and committees. The chairman and assistant chairman must be approved by the church at the September business meeting as they will serve as President and Vice-president respectively of the Corporation.

#### Section 4. Moderator

The pastor shall serve as moderator. In the absence of the moderator, the chairman of deacons shall preside, or in the absence of both, assistant chairman of deacons shall preside. In the absence of all three, the clerk shall call the church to order and an acting moderator shall be elected.

Section 5. Clerk

The church-elected clerk of the church shall keep in a suitable book a record of all the actions of the church, except as otherwise herein provided. The clerk is responsible for keeping a register of the names of members, with dates of admission, dismission, or death, together with a record of baptism. The clerk shall issue letters of dismission voted by the church, preserve on file all communications and written official reports, and give legal notice of all meetings where such notice is necessary, as indicated in these bylaws. The church may delegate some of the clerical responsibilities to a church secretary. All church records are church property and should be filed in the church office.

The clerk shall also keep the Corporate Seal and attest the signatures of officers of the corporation.

Section 6. Treasurer

The church shall elect annually a church treasurer, and an assistant treasurer. It shall be the duty of the treasurer to receive, preserve, and pay out all money or things of value paid or given to the church for any and all purposes, keeping at all times an itemized account of all receipts and disbursements. All bills will be paid by check in accordance with instructions contained in operational manual. It shall be the duty of the treasurer to render to the church at each regular business meeting an itemized report of the receipts and disbursements for the proceeding month. The treasurer's report shall be audited annually by an auditing committee.

Upon rendering the annual account at the end of the fiscal year, and its acceptance and approval by the church, the records shall be delivered by the treasurer to the church clerk, who shall keep and preserve the account as a part of the permanent records of the church.

Section 7. Corporate Officers and Board

The corporate officers shall be the Chairman of Deacons as President; Assistant Chairman of Deacons as Vice-President; Church Clerk as Secretary of Corporation; and Church Treasurer as Treasurer of Corporation, Two (2) additional board members shall be nominated from the active deacons by the church nominating committee, to be elected annually at the September Business Meeting. All shall serve from October 1st through September 30th.

The Board of the Corporation shall have no power to buy, sell, mortgage, lease, or transfer any property without a specific vote of the church authorizing each action. It shall be the function of the officers to affix their signatures to legal documents involving the sale, mortgage, purchasing, or rental of property, or other legal documents when the signatures of the corporate officers are required, and to maintain an adequate insurance coverage on all church property.

### III. COMMITTEES AND COORDINATING GROUPS and a solypes

Section 1. General must set of the moltesage of settlemon somenit set

The church year begins on October 1 and ends on September 30.

All church committee members shall be recommended by the nominating committee and elected by the church unless otherwise indicated in the description below. The committee members shall serve on a three-year rotation system with one third to be elected each year except otherwise indicated. Committees that show members as non-rotating are to be elected annually and may succeed themselves. All committees and groups shall use as guide lines literature available from Church Literature Department, Baptist Sunday School Board unless directed otherwise by the church.

### Section 2. Church Council

- (1) The primary functions of the council shall be to recommend to the congregation suggested objectives and church goals; to review and coordinate program plans recommended by church officers, organizations, and committees; to recommend to the congregation the use of leadership, calendar time, and other resources according to the program priorities; and to evaluate program achievements in terms of church goals and objectives.
- (2) The council, unless otherwise determined by vote of the church, shall have as regular members, the pastor, minister of education, minister of music, Sunday School director, Church Training director, Woman's Missionary Union director, Baptist Men's director, director of Recreation, and chairman of deacons. Committee chairman and church elected officers shall serve as ex-officio members.

(3) All matters agreed upon by the council, calling for action not already authorized, shall be referred to the church for approval or disapproval.

### Section 3. Nominating Committee and sures has abroper erouses has Ilul

The nominating committee consisting of 6 members shall coordinate the staffing of all church leadership positions that are filled by volunteers. The nominating committee recommends persons for all volunteer positions whenever a vacancy occurs, to be elected by the church.

### Section 4. Personnel Committee

The personnel committee of 6 members assists the church in matters related to employed personnel administration. Its work includes such areas as determing staff needs, employment, salaries, benefits, and personnel services.

### Section 5. Trustees (Properties Committee)

The trustees, consisting of 6 members, assists the church in matters related to properties administration. Its work includes such areas as maintaining all church properties for ready use, recommending policies regarding use of properties, recommending employment of maintenance personnel, and assigning responsibility to appropriate personnel for supervision. No property to be removed from premises without consent of trustees.

### Section 6. Finance Committee Committee

The finance committee, in connection with the church council, shall prepare and submit to the church for approval an inclusive budget, indicating by items the amount needed and sought for all local and worldwide expenses. The finance committee shall administer the budget, and shall develop and recommend an overall stewardship program. The treasurer, assistant treasurer, and at least one active deacon shall serve on this committee. The committee shall consist of five members and be non-retating.

### Section 7. Mission Committee 25 2 Tedmom works toly assistanted . bejon bat

The missions committee of 3 members seeks to discover possibilities for local missions projects, shares findings with church program organizations, and serves the church in establishing and conducting such missions projects as may be assigned to it.

### Section 8. Kitchen Committee

The kitchen committee of 3 members is responsible for formulating and recommending to the church policies for the kitchen and for communicating these policies to church members.

### Section 9. Church Ushers o same of all strong voides as your plant

Every regular church usher shall be selected by the nominating committee and elected by the church. The usher shall be led by an usher chairman, also selected by the nominating committee and elected by the church. The ushers are to greet people as they enter and leave the church, seat people at the proper time, provide bulletins and/or other materials at the time of seating. The ushers will be attentive to the needs of the congregation and the pastor.

### Section 10. History Committee

The history committee of three members (non-rotating) is to preserve and use the historical records of the church. The committee is especially concerned with gathering and preserving available church records, recording full and accurate records, and using the records to help members understand and appreciate their heritage and mission.

The flower committee consisting of 3 members (non-rotating) of which one shall be the Church Secretary, is responsible for securing, arranging, and disposing of floral arrangements for church services, and funerals.

### Section 12. Bus Committee

The bus committee of 6 members shall administer the bus policies as approved by the church. The committee will be attentive to the needs of the Church Recreation Staff.

### Section 13. Youth Committee (soffice Constitute) section 3.

The youth committee to be composed of Minister of Youth, Department Directors in youth division of Sunday School, Church Training, and one young person from each department to be recommended by Departmental Leaders to the nominating committee for church approval, shall assist in budgeting and planning,

The grustees, consisting of 6 members, assists the church

and implementing comprehensive youth program in the church spanning all church program areas involving youth. The committee shall elect their chairman, who will also serve as Youth Group representative to the Recreation Director.

Section 14. Lord's Supper Committee

The Lord's Supper committee shall prepare the elements and the equipment for the observance of the Lord's Supper. This committee is responsible for the preparation and maintenance work needed to observe the memorial service. The Lord's Supper will be onbserved on a schedule approved by the church. The committee shall consist of 4 deacons and wives (non-rotating).

The baptism committee shall consist of three deacons and three wives of deacons. It shall be the duty of this committee to make all necessary arrangements for the Ordinance of Baptism and to render such assistance to the pastor and to the candidates as may be necessary.

Section 16. Evangelism Committee

This committee shall assist in keeping an accurate list of lost and unchurched prospects living in our community. It shall seek to win and enlist these people to Christ and His church through promotion of an active visitation program. This committee with the advice of the Bastor shall have the responsibility of recommending to the church the need, date, and the leadership for all church revivals. Committee will consist of three active deacons.

The elected staff of program services shall be recommended by the church nominating committee for election by the church. The staff shall consist of Director of Church Recreation Service, and Director of Church Library Service. They shall coordinate their services under the guidance of the Pastor and/or Staff Member assigned by the church.

Section 2. Church Recreation Service and fordered and finder, band as passed

The recreation staff shall consist of age-group representatives, consultants of committees as required and will serve the church in seeking to meet the recreational needs of members and groups. They will provide recreation activities and provide consultation, leadership assistance, and resources.

Section 3, Church Library Services

The church library will serve as the resource center for the church. The church library staff will consist of director and audio visual consultant and library assistants, and will seek to provide and promote the use of printed and audiovisual resources. The staff will also provide consultation to church leaders and members in the use of printed and audiovisual resources.

Section 1. General

All organizations of the church shall be under church control, all officers being elected by the church and reporting regularly to the church.

Section 2. Sunday School

There shall be a Sunday School, divided into departments and classes for all ages and conducted under the direction of the Sunday School director for the study of God's Word. The task of the Sunday School shall be to teach the biblical revelation; reach persons for Christ and church membership; perform the functions of the church within its constituencey; provide and interpret information regarding the work of the church and denomination.

Section 3. Church Training

There shall be a Church Training organization divided into departments for all ages and conducted under the direction of a general director. The Church Training shall serve as the training organization of the church. The tasks of the Church Training shall be to orient new church members; train church leaders; teach Christian theology, Christian ethics, Christian history, and church polity and organizations; provide and interpret information regarding the work of the church and denomination.

Section 4. Woman's Missionary Union

There shall be a Woman's Missionary Union with such officers and organizations as needed. The task of the Woman's Missionary Union shall be to teach missions; engage in mission action; support world missions through praying and giving; provide and interpret information regarding the work of the church and denomination.

Section 5. Baptist Men

There shall be a Baptist Men's Group with such organizations as needed. This program shall be directed by a director. The tasks are to teach missions; engage in mission action; support world missions through praying and giving; provide and interpret information regarding the work of the church and the denomination.

There shall be a church music program under the direction of the music director. Such officers and/or organizations shall be included as needed, and elected by the church. #### VIII. CHURCH FINANCES

Section 1. Finance Committee

The finance committee, in consultation with the church council, shall prepare and submit to the church for approval an inclusive budget, indicating by items the amount needed and sought for all local and southwide expenses. Offering envelopes will be provided for members' use.

It is understood that membership in this church involves financial obligation to support the church and its causes with regular, proportionate gifts. This church shall teach the Christian stewardship of ones total life, and, at least annually, stress the stewardship of possessions.

Section 2. Accounting Procedures

All funds for any and all purposes shall pass through the hands of the church treasurer, or assistant treasurer, and be properly recorded on the books of the church. The officer (s) shall be bonded. A system of accounting that will adequately provide for the handling of all funds shall be the responsibility of the finance committee.

Section 3. Fiscal Year The fiscal year of the church shall run from January 1 and ends on December 31.

### CHURCH OPERATIONS MANUAL

Section 1. Organizational Chart

An organizational chart shall be prepared which will depict lines of responsibilty in the administration of the church. This chart shall be reviewed periodically and shall be revised as needed. A copy shall be included in the church operations manual.

Section 2. Policies and Procedures

Church policies andd procedures shall be described in the church operations manual. The manual shall be kept in the church office and made available to any member of the church. The manual shall be maintained by the church secretary. Changes in policies and procedures may be initiated by any church member or organization. Addition, revision, or deletion of church policies requires: (1) the recommendation of the church officer or organization (including committees) to whose areas of assignment the policy relates, (2) discussion by the church council, and (3) approval by the church. Procedures may be added, revised, or deleted by: (1) recommendation of the appropriate officer or group, (2) approval by the church council, and (3) approval of the church if deemed necessary by the church council.

Changes in this constitution and bylaws may be made at any regular business meeting of the church, provided each amendment shall have been presented in writing at a previous meeting, and copies of the proposed amendment be furnished to each member present. It is understood that membership in this church involves financial obligation to support the church and its causes with regular, proportionate gifts. This church shall teach the Christian stowardship of once total life, and, at least Paul Thompson came as Religious Education Director in 1961.

In 1962, another education building was dedicated. The new structure is primarily an elementary building, although it provides a few other departments. A total of 18 assembly rooms is provided. One wing has 5 nursery rooms. Also included is the office suite containing the pastor's study, offices for Minister of Education and Minister of Music/Youth, as well as an office for the church secretaries.

In 1965, the pastor's salary was \$7000. We had 1175 enrolled in Sunday School with an average attendance of 532.

Paul Thompson resigned to go to Calvary Church in Memphis, Tennessee.

We finished paying on the Knob Lick building in 1965. (\$1200)

In 1967, our pastor went to Ohio for a revival before the Southern Baptist Convention began in Detroit.

The church purchased the Harter/Swink property for \$15,000 in 1967.

Mel Lantz came as Associate Pastor in 1968. He left in February, 1970 to go to the Boonville Church as pastor.

The 1968 Annual Church Letter recorded 1,002 as total membership; 1,201 Sunday School enrollment with an average attendance of 529. Two morning services had been held for several years and plans are underway to build a new and adequate Sanctuary to replace the building which has been in use for the past 57 years.

Property value has reached \$435,000.00.





# About the Building ...

Facing College Street, the new educational building occupies the area immediately west of the other existing educational facilities. Taking advantage of its position, the architect has connected the two buildings at two different levels.

Built of a pink-tinted brick, and trimmed with mosaic tile, the building is contemporary in design. Large windows take up a great deal of the wall space on both floors so that the rooms are light and can be well ventilated.

Construction details for this educational unit include drilled pile foundations, masonry exterior walls, structural steel framing, steel bar joists, concrete floor slabs, accoustical plaster ceilings, vinyl and asphalt tile flooring, painted concrete block wall surface, aluminum sash and twenty-year tar and gravel roof over a poured gypsum deck. Hallways are covered with ceramic tile to a height of five feet. Storage units, coat racks, chalk and bulletin boads are builtin for various departments. A hot water heating system is centrally installed for both the new building and other existing facilities.

The new structure is primarily an elementary building, although it provides for Married Young People and one Adult department. A total of 18 departments or assemblies are provided. These are: Five Nurseries, three Beginners, four Primaries, four Junior, Married Young People, and one Adult. Also included in the building is the office suite containing pastor's study, offices of the minister of education, church secretary, educational secretary, and the church parlor.

Incividual class rooms are provided in the Junior, Married Young People and Adult departments. A total of four rest rooms are located in the building. In addition, the nurseries are equipped with a kitchenette and one large reception room which has entrances to all five nursery departments. The nursery section opens to an outside play court which is trimmed with a clay tile solar screen wall.

The entire nursery section as well as the office suite is completely air-conditioned.

Martin mentioned the need of a curtain or something in the old office because of disurbances. This was turned over to the Trustees. Bro. Scott mentioned the importance of deacons to get behind the whole church program, with emphasis on Brotherhood.

Bro. Holland closed the meeting with prayer.

### HISTORY OF THE KNOB LICK BAPTIST MISSION

A Baptist Church is a divine institution and is therefore worthy of a proper beginning. Is there a more proper beginning than to look to God's Holy Scriptures? In Deuteronomy we are admonisted to: "Remember the days of old, consider the years of many generations: ask thy Father and He will shew thee; thy elders, and they will tell thee." Also in Isaiah we find: "Look unto the rock whence you are hewn, and to the hole of the pit whence ye are digged." In clear terms God bids His people to study and transmit the story of bygone events, to learn and preserve their history. Thus as we carry out these commands it is hoped that the knowledge of the past may lead to glorious triumphs in the future.

The first Baptist work in Knob Lick which was affiliated with the Southern Baptist Convention took roots with the organizing of the Knob Lick Baptist Church on January 15, 1928. The church was organized with five charter members: Miss Hazel Jennings, Miss Hazel Wilkerson, Miss Bessie Kinney, Mrs. R. A. Murphy, and Mr. Elbert Menge. The first pastor of the church was Rev. Orville Steiner. He was called to pastor half-time on February 12, 1928. Other pastors of the church from 1928 to 1951 included C. W. Miller, Ebbert Menge, and Earl Winters.

This new Baptist Church held their services and worshipped in the church building owned and formerly used by the United Baptist Church of Knob Lick.

Trustees were elected by the church to negotiate the transferal of the property from the trustees of the Old United Baptist Church to the Knob Lick Baptist Church. This was done in May of 1929 and on May 26, 1929, Mrs. Sarah Clemons, trustee of the United Baptist Church, reported transferal of deed had been made. The trustees of the Knob Lick Baptist Church were Elbert Menge, Bert Williams, and James Plummer.

The members of the Knob Lick Baptist Church on October 21, 1951, unanimously voted to ask The First Baptist Church of Farmington to sponsor the Knob Lick Baptist work as a mission. The First Baptist Church of Farmington in business session on November 21, 1951, heard a report from the deacons concerning the Knob Lick Baptist request. The Farmington Church at that time, on recommendation from the deacons, voted to allow \$10.00 a week to aid the expenses of M. C. Menge, Pastor of the Knob Lick Baptist Church. Then on the following December 5, 1951, the deacons of the Farmington Church brought a recommendation to the church that the First Baptist Church of Farmington accept the Knob Lick Church as a mission. This recommendation was accepted by the Farmington Church, thus making the Knob Lick Baptist Church a part of First Baptist Church of Farmington. M. C. Menge, Pastor of the Knob Lick Baptist Church, then became the Pastor of Knob Lick Baptist Mission. Earl Winters became the second Pastor of the mission in January, 1952. Also in 1952 the Farmington Church sent Brother J. W. Stavens to serve as the Sunday School Superintendent. On March 5, 1962, just three months after the First Baptist Church assumed sponsorship of the mission, there was a Sunday School report given for the month of February which stated the average Sunday School attendance was 22. Mr. Stevens reported to the church in April of 1953 an average attendance of 41 with collections for the month of 196.37.

In December of 1953 Rev. John Wilkinson was called by the Farmington Church to be paster of the Knob Lick Mission to succeed Brother Winters. Brother Stevens continued to serve as Sunday School Superintendent until November of 1954 when he was succeeded by Brother Russell Burch from the Farmington Church. Mr. Burch's first report to the church concerning the Sunday School was 53 enrolled with 36 as an average attendance.

The Knob Lick Baptist Mission building was 71 years old in 1955 and it was in need of repairs. In January of 1955 the sponsoring church voted to borrow money from the Missouri Baptist Convention and use that money for an extensive remodeling of the mission building. The Knob Lick Building Committee was composed of Mrs. Grace Byington, Mr. Jim Easley, Mr. Ode Clemons, all of Knob Lick, and Lewis Monde and Russell Burch of the sponsoring church. The pastor, Rev. Wilkinson, was also on the committee. The remodeling was completed in three different stages, making the building larger and more useful. The foundation and roof was about all that remained of the old building. Brother A. M. Foreman of the Farmington Church became Sunday School Superintendent in early 1955 and served in that capacity until December 1960. Mr. Foreman was the last of three Sunday School Superintendents to serve the Knob Lick Mission from the sponsoring church. Others, not heretofore mentioned, who served the mission from First Baptist Church are Mrs. Helen Engle, Mrs. Mae Blaylock, and Mrs. Mayme Raglin.

Rev. Norman James on was called on August 14, 1955, to become Assistant Paster of the Farmington First Baptist Church and to be Paster of the Mission.

On September 12, 1956, Rev. Jameson resigned to accept a pastorate in Caruthersville, Missouri, and Rev. Herman Shumake was callED by the Earmington Church to be Pastor of the Knob Lick Baptist Mission. Bro. Shumake came as Pastor en October 1956, and has served as pastor till the present time.

The mission building in need of more educational space was added to in the latter part of 1957. This came as the result of a vote by the Farmington Church on September 11, 1957. The Building Committee was composed of Mr. A. M. Foreman, Mr. Lewis Monie, Mr. Jim Easley, and Mr. Ode Caemons.

The mission under the pastoral leadership of Rev. Shumake has stemily grown and looked forward to the time that it could be a self-supporting autonomous church. Rev. Shumake came to the mission when the yearly enrolment in Sunday School was 55 with an average attendance of 22. It rose to a peak in June of 1961 with an enrolment of 190 and an average attendance of 85. Last year the associational letter reported an enrolment of 142 with an average attendance of 62.

In November of 1964 the people of the Knob Lick Mission petitioned the sponsoring church, First Baptist Church of Parmington, to allow the mission to be organized into a church during the Spring of 1965.

The First Baptist Church in business session on December 2, 1964, accepted a recommendation from the deacons that the church look with favor on the prospects of Knob Lick Mission becoming a Church. At the business meeting of the Parmington Church on May 5, 1965, the deacons recommended that the Knob Lick be constituted into a church on May 16, 1965, at 2:80 P.M. The motion was made, seconded, and carried.

The First Baptist Church of Farmington then began to plan for the organizational services to be held on May 16, 1965, at Knob Lick Baptist Mission.

The preceding history, although factual and accurate, is not complete in detail and was not intended to be a critical paper or a scholastic work. It was intended to show how God has blessed the people and work of the Knob Lick Baptist Mission - to show how He has blessed the labor of love in this community; and

WHEREAS this history shows a definite growth, and;

WHEREAS many can testify to the good works of the Knob Lick Baptist Mission, and;

WHEREAS this mission is already self-supporting in many areas of work, and;

WHEREAS the people of Knob Lick Baptist Mission have stated their desire and demonstrated their willingness to be self-governing, and;

WHEREAS The Baptist Witness of a self-governing, self-supporting autonomous Baptist Church will be a blessing unto God and His Kingdom, the First Baptist Church of Farmington recommends that the Knob Lick Baptist Mission be constituted into the First Baptist Church of Knob Lick, Missouri.

# "Pon't Call on Me to Pray"

"I'll do anything I can to serve," a young deacon said to his pastor, "but please don't call on me to pray. It isn't that I don't want to. Just the thought of it almost scares me to death."

Because the deacon seemed to want to overcome his fear, the pastor asked if he had family worship in his home. When the deacon apologetically answered no, he was urged to begin.

"It won't be easy at first," the pastor warned him, "but don't give up. I promise that you will find it worth whatever it takes"

Just before the children were ready for bed that night, the man and his family paused for a brief devotion. The mother read a few verses from the Sermon on the Mount. Then the father tried to pray.

He found that the words did not come easily. Praying aloud in the presence of his family was more difficult than he had anticipated. He muttered a few words and hurriedly ended the prayer in embarrassment.

He was ready to forget the whole idea, but he remembered the plea of his pastor that he not become discouraged. The next time his prayer came a bit easier. Soon he was praying with confidence. Several months later, when his pastor called on him to pray, the deacon responded with scarcely a tremor.

This is the usual result when church members pray daily by families—both church and home benefit. In those homes where there is daily worship, family living is enriched. And members of those families are trained for more effective service in their church.

When church members worship daily by families, they learn the meaning and worth of participation in worship. In the intimate circle of the family, they cannot stand apart and observe. They are caught up in the spirit of praise and thanksgiving. Parents and children alike share in the responsibility of making their worship acceptable to God.

Worship is at the heart of the church. Other functions are related to this one. Worship involves Bible study, prayer, meditation, self-examination, dedication, commitment, and other aspects of the Christian life.

Just as the child cannot receive adequate spiritual training during an hour or two at the church on Sunday, neither can the mature Christian worship adequately if this experience is confined to the church. A church needs the experience of worshiping daily by families. This is vital to the Christian.

Jolly's "mail" also included a package of golf balls from Elmer Brown, a fellow duffer by his own admission.

Mrs. R. L. Merseal, church secretary during Rev. Jolly's 10-year tenure, summed up the latter's accomplishments with facts and figures from the office files. During the period 1,091 additions to the membership were reported, 482 by baptism and 609 by transfer of letters. Elmer Brown presented a check to the Jolly family at the close of the program.

In response Rev. Jolly modestly declared, "I'm glad I was here when all these things happened." He added that he was grateful for the privilege of serving the church these past 10 years.

Two of the church choral groups, the adult choirs under

the direction of Bob Dugal and a children's choir directed by Miss Julie Smith, sang appropriate numbers.

### Many Gains Made

Church membership increased by 403 during the past 10 years, 1,326 in 1963 as compared with 923 in 1954. The Sunday School figures for the same period; 1005 enrolled with an average attendance of 472 in 1954 increased to 1308 enrolled in 1963, average attendance 612.

Financial support likewise showed a big increase during this period. In 1954 the total gifts were 442,997 for the year; in 1963 this had increased to \$86,125. Total giving for the 10-year period was \$725,146, and of this amount \$201,196 was given to missions, according to the figures compiled by Mrs. Merseal.

In her "letter" to Rev. Jolly, Mrs. Merseal also listed the following accomplishments:

A cabin was built at Bates Creek; a building was built at DeLassus Mission and one at Knob Lick Mission; a lot was bought for the associational missionary's home, four pieces of property were bought, a new educational building was built; a parking lot was provided; the sanctuary was redecorated; pew cushions were bought and all the buildings are being air-conditioned at this time.

John Wilkinson was recommended by this church to the Southern Seminary at Louisville

Two ministerial students were recommended to Bolivar, Richard Scott and Don McGuire

One ministerial student was recommended to William Jewell, Larry Matthews

An assistant pastor, Rev. N. L. Jameson, came to be with the church from August 14, 1955 to September 12, 1956

Paul Thompson came as educational director August 1, 1961 and was ordained a Minister of Education on May 16, 1962.

Don McGuire was licensed to preach on December 12, 1962.

The church is paying part of the salaries of two foreign missionaries - Frances Crawford and Virginia Nell Smith.

The church secretary concluded her tribute with references to Rev. Jolly's service to the Southwest Baptist College at Bolivar as a member of the board of directors for a number of years. Rev. Jolly also gave "faithful and

valuable service during many years" as a member of the board of trustees of Southern Seminary at Louisville, Ky.

The Sunday evening tribute to Rev. Jolly was planned by the Church Council, composed of the church staff and heads of the various groups in the local church. The plans were executed by a committee of women including Mrs. Ernest Towler, Mrs. Paul Thompson, Mrs. Bob







### First Baptist Church Featured In Associational Publication

The First Baptist Church of Farmington is recognized as the Church of the Month in the most recent issue of Observer and Helper, Franklin Baptist Association publication.

The church was organized March 18, 1882, Articles of Faith and rules of decorum were adopted in accordance with those of the Union Baptist Church, now known as Three Rivers. The Union Church, then the strongest Baptist Church in the Franklin Association had been receiving members at Farmington since 1838. Instrumental in the organization were: Elders James G. Hardy and James F. Baker. Charter members, in addition to Elders Hardy and Baker were: Theoclia Hardy, Ambia W. Hardy, Elize Lloyd, Lizzie Loyd, Martha Turley, Mat-tie Baker, Dora Easley and Elizabeth Resinger.

James G. Hardy was elected as pastor and James F. Baker as clerk. Meetings were Saturday before the second Sunday. First meetings were in the Christian Church, then in the Methodist churches and later in the old Farmington Baptist College January 1906. A number of changes and progressive moves were made during Mr. Brite's pastorate. A Mission Society, in addition to the Ladies Aid Society, was organized in 1905. In February 1907 a building committee was formed to investigate the advisability of re-modeling or rebuilding.

The panic of 1907 hindered finances, but the building fund grew. The property south of the church was purchased for a parsonage and on April 2, 1911, a new brick building was realized at a cost of approximately \$10,000. It was dedicated September 30, 1917 and this building serves as the sanctuary of the church today.

The Rev. V. E. Patterson was elected pastor March 16, 1913. A marked growth in membership was in evidence in 1914 with 247 members. In November of 1913 there had been a revival, which resulted in 54 additions, 31 by baptism.

July 22, 1914, the Rev. O. H. L. Cunningham became pastor. Two names reappear as clerk through many years of service Miss Anne Menge and Oscar remained until 1943 when Rev. R. Ray Stone became pastor.

In 1946 the church voted unanimously to start a new building. This same year they accepted Brightstone as a mission. This mission became incorporated in 1947. An educational building, attached to the rear of the church, was dedicated June 5, 1949, with Dr. T. W. Medearis, Executive Secretary of Missouri Baptist, bringing the message.

In 1951, Dale Brubaker, who is now Director of Music Dept. for Missouri Baptist, was employed as Minister of Music. The Rev. Stone completed a very successful ten year pastorate in December 1953. The membership had grown to 905 with a Sunday School of 919. The church was also sponsoring two missions, one at Knob Lick and another at DeLassus.

The present pastor, the Rev. J. Loren Jolly, accepted the call of the church in 1954. The past 14 years have been marked by continued progress. As the Sunday School grew, it was necessary to use the public school building and four houses near the

Rantzed in 1989.

James G. Hardy was pastor until 1887. The Rev. J. B. Hepler, of Mexico, Mo., was called January 1888, on a fourth-time basis. Minutes indicate that many were received into the membership and baptismal services were regularly. According to records, the membership was 57 in 1887 with 20 members received during that year. First deacons elected in 1888 were: Brethren W. H. Morris and V. C. Clav.

The Rev. I.R.M. Beeson became pastor in 1889. Lack of finances plagued the church for many years and early records tell of taking subscriptions to

pay the pastors.

J. W. Campbell, who was associated with the Farmington Baptist College, became pastor in December 1890. In August 1892 F. W. Shoush came as pastor. During this year a building committee was appointed and their first church home, a frame structure was built on the present site. The building was dedicated in 1839 and the Franklin Association met, in their annual meeting, with Farmington for the first time.

Half-time services were started in 1893 & the first Treasurer, W. A. Cloud, was elected that year. E. A. Spring accepted the call of the church in May 1894 at a salary of \$200.00 annually with a like amount to be received from the State Board. Rev. Spring resigned in 1896 and, in April, J. W. Campbell returned as pastor. He served until September when M. M. Munger acepted the pastorate.

The first ordination service was January 16, 1896, ordaining E. L. Curle to the gospel ministry. Total membership was 100 in 1898 and value of church pro-

perty was \$1000.

The Rev. Munger was re-called by the church on December 1898 for full-time service and remained with the church until 1900, when, in November, W. G. Reeves became pastor and the church went back to half-time services.

The first B.Y.P.U. (Baptist Young People's Union) was organized in 1901. The Rev. Reeves declined the call to pastorate for another year and Rev. J.D. Watson accepted the call. He remain ed until October 1902 and C. L. Bullard of Louisville, Ky. accepted he church pastorate in March 1903 at a salary of \$700.00. Membership was now 144 and Sunday School enrollment was 126.

The Rev. W. M. Rudolph was elected pastor November, 1904. He served one year, then the Rev & P. Brite accepted the call in

his work as pastor in 1921, followed by Rev. G. C. Greenway the next year. Membership was 497 in 1923, making Farmington the second largest church in the Association, Flat River having 577.

The Rev. J. W. Jeffries became pastor in 1927. The first Vacation Bible School was held the following year. Named faithful during the 20's were: J. G. Newman, Chorister; Virginia Morris, Pianist; E. J. Hunt, clerk; W. L. Johns, Sunday School Supt. and Mrs. Russell Ryan, W.M.U. President.

The Rev. E. H. Zipprodt was elected pastor in 1930. The following year, Rev. F. Q. Crockett was called; also that year Elbert Menge was ordained to the ministry.

The church celebrated their 50th anniversary in September 1932. Dr. Edgar Godbold, then Supt. of Missouri Baptist General Association headquarters, in Kansas City, was the speaker.

Minutes of July 1934 list Dr. L. M. Stanfield as Financial Secretary and Robert Dugal as Chorister. These men serve in like capacity in the church today.

A Hammond Electric organ was purchased in 1938 and the church adopted the Minister's Retirement plan the same year.

The Rev. W. P. Young, of Texarkana, Texas, accepted the call of the church in May of 1939 and


the present educational building which was completed in 1962.

The church was able to finance and support building work at Knob Lick and DeLassus. These missions are now constituted churches. Norman Jameson became first educational director, Paul Thompson served several years as Minister of Education, and at present, Rev. Mel Lantz serves as Associate Pastor.

Mrs. Nora Merseal became church clerk in 1946 and has served in this capacity since, as well

as church secretary.

Many familiar family names, recorded through the years from the early church are still much in evidence today in faithful and loyal service in the work at First Baptist Church, Farmington.

It is a common practice nowadays for mothers to go to work when their children reach school age but not too many homemakers of 50 years ago had the inclination or skills to supplement the family income. Mrs. Webb will be 82 on March 11, 1964, and has been retired from gainful employment for many years now. She is not, however, a dozing octogenarian with waning interest in the world about her. On the contrary, Mrs. Webb continues to improve her fine mind by reading, travel and absorbing hobbies.

Mrs. Webb has two preferred means of getting where she wants to go. If the distance is within a mile or so and she has time—she will walk; for greater distance she elects jet flight travel. This quality of energetic directness somehow typifies the charming Mrs. Webb, reporter for the Lead Belt News and then the Farmington News

Love, she was born by the headwaters of Black River in the community of Edge Hill, Mo. It was there that she attended school and, with no more formal training than her eighth grade education, served as teacher of the school for two years—beginning when she was 17 years old. With her characteristic determination, the teen aged instructor tackled the job of teaching pupils of grades one through eight in a single room. Some of her students stood head and shoulders above the young teacher. With several grades under her direction, she had to budget her time to 20 minutes per class.

Reversing the usual procedure, Alice went to high school after teaching for two years. When the Love family moved from Edge Hill to a farm near Ironton, Alice became a student again, taking advantage of the two years of high school work being offered at Ironton. She then returned to teach two more terms at the Edge Hill school.

James M. Webb, former school teacher and farmer, and Alice Love were married Dec. 28, 1904, at the home of the bride's parents. For the first years of their marriage the young couple lived on the Edge Hill farm which had been owned by the Love family for over 100 years. It was here that the first child, a daughter named Ruth, was born. The second child and only son, William R. Webb, was born after his parents left the farm and moved to St. Louis. During the family's 21/2-year residence in St. Louis, Mr. Webb was employed as a street car motorman. In the spring of 1909, the family moved to Flat River and Mr. Webb went to work for the St. Joseph Lead Company, beginning a period of employment that continued for 391/2 years. The third and last child, a daughter named Hilda, was born during the family's 31-year stay in Flat River.

The children were all in school when Mrs. Webb took on the assignment as reporter for the Lead Belt News. For the next 7½ years she was a newswriter as the paper changed hands from Cameron to Womack, Womack to Womack-Bouchard, and then to W. L. Bouchard, present editor and publisher. Shortly after resigning her duties at the Lead Belt News, Mrs. Webb started another 7½-year stint as reporter for the late Harry Denman on the Farmington News. Mr. and Mrs. Webb moved to Farmington in 1940 and lived out the remaining portion of almost 54 years of married life. Mr. Webb passed away Sept. 9, 1958. Now making her home with Mrs. Webb at 506 N. Jackson St., Farmington, is her sister, Miss Florence Love, retired dietitian and graduate of Columbia University, New York.

When asked about her newspaper work Mrs. Webb recalled that she first started writing short "locals" and later covered more lengthy stories of weddings, deaths and other events that made up the week's news. Trips on foot from Flat River to Desloge and Elvins were not unusual feats for Mrs. Webb when she needed to make contacts in outlying sections.

A notable difference of newswriting then and now was that the reporter visited homes on both sad and joyous occasions and obtained on-the-spot information. There was a great deal more leeway in descriptive techniques and conclusions that could be drawn by the writer without fear of libel suits. The "suspects" alluded to today were

### Church of the Month— First Baptist Church of Farmington

The First Baptist Church of Farmington was organized March 18, 1882. Articles of Faith and rules of decorum were adopted in accordance with those of the Union Baptist Church, now known as Three Rivers. As early as 1838 the Union Church, then the strongest Baptist Church in the Franklin Association, had been receiving members at Farmington. Instrumental in the organization were Elders James G. Hardy and James F. Baker. Charter members, in addition to Elders Hardy and Baker were: Theoclia Hardy, Ambia W. Hardy, Eliza Lloyd, Lizzie Lloyd, Martha Turley, Mattie Baker, Dora Easley and Elizabeth Resigner.

The church elected James G. Hardy as pastor and James F. Baker as Clerk at this organizational meeting. Saturday before the second Sunday become the regular meeting time for the church. They first met in the Christian Church, then in the Methodist churches and finally in the old Farmington Baptist College Chapel. They had no home of their own for eleven years. A Ladies Aid Society, the first in Farmington, was organized in 1885. James G. Hardy remained pastor until November 1887.

In January 1888 Rev. J. B. Hepler from Mexico, Mo. was called on a fourth time basis. Pastors were then given a "yearly call," which was the custom of that day. The early records tell of withdrawing fellowship and excluding members from time to time for misdemeanors, drinking, disputes and disrepectful behaviour. Minutes state also that many were received into the membership and baptismal services were held regularly. Membership recorded in 1887 was a total of 57 with 20 members received in that year. First deacsons were elected in 1888—Brethren W. H. Morris and V. C. Clay.

In January 1889 Rev. I.R.M. Beeson became pastor. Salary was designated at \$150.00 per year. Lack of finances plagued the church for many years and early records tell of taking subscriptions not only for the present pastor's salary but also to pay delinquency for the past pastor. J. W. Campbell accepted the call of the church in December 1890. Brother Campbell was associated with the Farmington Baptist College.

In August 1892 F. W. Shoush came as pastor. This year a building committee was appointed and their first church home, a frame structure on the present site, was built. The building was dedicated in 1839 and the Franklin Association met in their annual meeting with Farmington for the first time.

By vote of the church in November 1893 half-time services were started. The first Treasurer, W. A. Cloud was elected in 1893. E. A. Spring accepted the call of the church in May 1894 at a salary of \$200.00 annually with a

like amount to be received from the State board. Brother Spring resigned in January 1896 and in April J. W. Campbell returned as pastor. He served until September when M. M. Munger accepted the pastorate.

The first ordination service was held January 16, 1896, ordaining E. L. Curle to the gospel ministry. Total membership as reported in 1898 was 100 and value of the church's property was \$1,000. Brother Munger was re-called by the church on December 1898 for full time service and he remained with them until August 1900. In November of that year W. G. Reeves moved to Farmington as pastor and the church went back to half-time services.

In September 1901 the church voted to let the young people of the church organize a B.Y.P.U. Rev. Reeves declined the call of the year for the coming year and call was accepted by Rev. J. D. Watson. He stayed until October 1902. C. L. Bullard was called for one year in March, 1903. He came from Louisville Ky., at a salary of \$700.00. Membership was now 144 and the Sunday School enrollment was 126.

Brother W. M. Rudolph was elected pastor November 7, 1904. He resigned in November the next year and Rev. S. P. Brite accepted the call extended him in January 1906. Though the associational minutes of 1906 record a membership of 158 in 1907 it had declined to 132. Cause was a revision of the church roll, which became a regular practice. A number of changes and progressive moves were made during Brother Brites pastorate. A Mission Society, in addition to the Ladies Aid Society was organized in 1905. In February 1907 a bulding committee was formed to investigate the advisability of re-modeling or re-building.

The panic of 1907 hindered finances but the building fund grew. The property south of the church was purchased for a parsonage and on April 2, 1911 a new brick building was realized at a cost of approximately \$10,000. It was dedicated on September 30, 1917 and this building serves as the sanctuary of the church today.

Rev. V. E. Patterson was elected pastor March 16, 1913 at a salary of \$680.00 and parsonage. A marked growth in membership was in evidence in 1914 with 247 members reported. Minutes record a revival in November of 1913 in which there were 54 additions, 31 of them by baptism.

July 22, 1914, Rev. O. H. L. Cunningham was unanimously elected pastor. Two names reappear as Clerk of the church through many years of service—Miss Anne Menge and Oscar Haile. Another great ingathering of members was experienced in August 1916 when 66 persons were received. Membership totaled 326 in 1916. The

minutes of January 10, 1917 name at least 30 persons who were "excluded for non-attendance and non-payment of dues." Also two persons were excluded for misconduct. Rev. Cunningham left Farmington in March, 1921 and in April Rev. J. J. Schuler began his work as pastor at a salary of \$1,500 for an indefinite period. He was succeeded in July, 1922 by Rev. G. C. Greenway.

A letter was sent to all members dated July 19, 1922, (copy attached in minutes book), encouraging them to attend and support church financially and to reply as to intent. If member did not respond, name was stricken from the roll. This was a regular practice for a number of years by consent of the church. Membership total was 497 in 1923, making Farmington the second largest church in the Association. (Flat River Membership then 577).

Rev. Greenway resigned October 1926 and Rev. J. W. Jeffries became pastor in 1927. A budget totaling \$6,000 was adopted by the church for 1928, \$2,400 was designated salary and \$2,750 for missions. The first Vacation Bible School was held in 1928 with a daily attendance from 90 to 120. Named faithful in service during the 20's were: J. G. Newman, Chorister, Virginia Morris pianist, E. J. Hunt, Clerk, W. L. Johns Sunday School Supt. and Mrs. Russell Ryan, W.M.U. President.

Brother Jeffries completed his work in September 1929 and Rev. E. H. Zipprodt was elected pastor in January 1930. The following year, Rev. F. Q. Crockett was called following the resignation in March of Rev. Zipprodt. Elbert Menge was ordained to the gospel ministry in June. 1931.

The church celebrated their 50th Anniversary in September 1932. Dr. Edgar Godbold, then Supt. of Missouri Baptist General Association headquartered in Kansas City, was the speaker.

Minutes of July 1934 list Dr. L. M. Stanfield as Financial Secretary and Bob Dugal as Chorister. These men serve in like capacity in the church today. An exceptional revival was held June 1935 when 45 were added to the membership, 32 coming by experience and Baptism. Total membership reported in 1935 was 409. By vote of the church in November 1937 percentage giving for missions was increased to 23% of undesignated gifts. A Hammond Electric organ was purchased in February 1938 and the church adopted the Minister's Retirement plan this year. Rev. Crockett tendered his resignation effective in April 1939.

Rev. W. P. Young of Texarkana Texas accepted the call of the church in May 1939 and remained until 1943. The church then called Rev. R. Ray Stone. Membership was recorded this year at 534, Sunday School Enrollment of 360 and property valued at \$26,000.

On Sept. 25, 1946 the church voted unanimously to start on a new building as soon as possible. This same year the church accepted Brightstone as a mission. The Church became incorporated in 1947. An educational building attached to the back of the auditorium was dedicated on June 5, 1949 with Dr. T. W. Medearis, Executive Secretary of Missouri Baptists bringing the message.

In 1951 a minister of music was employed, Dale Brubraker, who is now Director of Music Dept. for Missouri Baptists. Rev. Stone completed a very successful ten year pastorate in December 1953. The membership had grown to 905 with a Sunday School of 919, Training Union of 224, W.M.U. of 269. The church was also sponsoring two missions, one at Knob Lick and another at Delassus.

The present pastor, Rev. J. Loren Jolly accepted the call of the church extended in February 1954. The past 14 years have been marked by continued progress. The Sunday School growth to 1,005 in 1954 necessitated using the public school building and four houses surrounding the church were purchased and used for Sunday School space until razed to make way for the present educational building which was completed in 1962.

Along with their own extensive building program the church was able also to finance and support building work at Knob Lick Mission and the construction of a new building at Delassus. These missions have now become constituted churches. Growth in Stewardship at the church has been evidenced during these years with mission gifts far surpassing dreams of the early church. Norman Jameson become first educational director employed by the church and Paul Thompson served several years as a minister of Education and at present, Rev. Mel Lantz serves as Associate Pastor. Mrs. Mira Merseal became Church Clerk in October 1946 and has served in this capacity since as well as Church Secretary.

Membership, as recorded in the 1968 minutes, totals 1,002 with Sunday School enrollment of 1,201 and an average attendance of 529. Two morning services have been held for several years and plans are underway to build a new and adequate Santuary to replace the building which has been in use for the past 57 years. Property

Our second reason for being is to lead persons to participate in missions. Have we in our life time ever had a mission cause in which we could be more personally envolved? A visitation program should already be in progress to enlist people in Bible study to prepare their hearts for the harvest in March. Now is the time to show our concern. Two weeks in a year doesn't convince people we are very much concerned. One of my children, with some other young people from the church, went to visit a high school class mate during a revival. He expressed to them in word what I'm sure others must have felt. You don't really care about me. The only time your church shows an interest in me is during a revival." They didn't reach him either. Are we now participating in prayer in proportion to our concern? How earnestly are you praying?

Our third task, give leadership to special mission projects. The Crusade is special, it is missilnary and we surely should be willing to lead in prayer groups, visitation and anything that will involve as many people as possible to get them ready for the harvest. The fourth reason for our organization is to interpret information regarding the work of the church and the denomination. The Crusade should so possess us that we just can't help talking about it. We'll want to tell all Christians we need their help and tell them how they too can help. We'll want to tell the lost that the Crusade is for them because we love them and want them to know our Christ as their Savi-

If Christ has first place in our heart then the Crusade of the Americas will possess our interest, prayers, concern and time. And our planning should entail Crusade purposes until it is over. So much depends on the success and the success depends on us.

### Church of the Month— First Baptist Church of Farmington

The First Baptist Church of Farmington was organized March 18, 1882. Articles of Faith and rules of decorum were adopted in accordance with those of the Union Baptist Church, now known as Three Rivers. As early as 1838 the Union Church, then the strongest Baptist Church in the Franklin Association, had been receiving members at Farmington. Instrumental in the organization were Elders James G. Hardy and James F. Baker. Charter members, in addition to Elders Hardy and Baker were: Theoclia Hardy, Ambia W. Hardy, Eliza Lloyd, Lizzie Lloyd, Martha Turley, Mattie Baker, Dora Easley and Elizabeth Resigner.

The church elected James G. Hardy as pastor and James F. Baker as Clerk at this organizational meeting. Saturday before the second Sunday become the regular meeting time for the church. They first met in the Christian Church, then in the Methodist churches and finally in the old Farmington Baptist College Chapel. They had no home of their own for eleven years. A Ladies Aid Society, the first in Farmington, was organized in 1885. James G. Hardy remained pastor until November 1887.

In January 1888 Rev. J. B. Hepler from Mexico, Mo. was called on a fourth time basis. Pastors were then given a "yearly call," which was the custom of that day. The early records tell of withdrawing fellowship and excluding members from time to time for misdemeanors, drinking, disputes and disrepectful behaviour. Minutes state also that many were received into the membership and baptismal services were held regularly. Membership recorded in 1887 was a total of 57 with 20 members received in that year. First deacsons were elected in 1888-Brethren W. H. Morris and V. C. Clay.

In January 1889 Rev. I.R.M. Beeson became pastor. Salary was designated at \$150.00 per year. Lack of finances plagued the church for many years and early records tell of taking subscriptions not only for the present pastor's salary but also to pay delinquency for the past pastor. J. W. Campbell accepted the call of the church in December 1890. Brother Campbell was associated with the Farmington Baptist College.

In August 1892 F. W. Shoush came as pastor. This year a building committee was appointed and their first church home, a frame structure on the present site, was built. The building was dedicated in 1839 and the Franklin Association met in their annual meeting with Farmington for the first time.

By vote of the church in November 1893 half-time services were started. The first Treasurer, W. A. Cloud was elected in 1893. E. A. Spring accepted the call of the church in May 1894 at a salary of \$200.00 annually with a

like amount to be received from the State board. Brother Spring resigned in January 1896 and in April J. W. Campbell returned as pastor. He served until September when M. M. Munger accepted the pastorate.

The first ordination service was held January 16, 1896, ordaining E. L. Curle to the gospel ministry. Total membership as reported in 1898 was 100 and value of the church's property was \$1,000. Brother Munger was re-called by the church on December 1898 for full time service and he remained with them until August 1900. In November of that year W. G. Reeves moved to Farmington as pastor and the church went back to half-time services.

In September 1901 the church voted to let the young people of the church organize a B.Y.P.U. Rev. Reeves declined the call of the year for the coming year and call was accepted by Rev. J. D. Watson. He stayed until October 1902. C. L. Bullard was called for one year in March, 1903. He came from Louisville Ky., at a salary of \$700.00. Membership was now 144 and the Sunday School enrollment was 126.

Brother W. M. Rudolph was elected pastor November 7, 1904. He resigned in November the next year and Rev. S. P. Brite accepted the call extended him in January 1906. Though the associational minutes of 1906 record a membership of 158 in 1907 it had declined to 132. Cause was a revision of the church roll, which became a regular practice. A number of changes and progressive moves were made during Brother Brites pastorate. A Mission Society, in addition to the Ladies Aid Society was organized in 1905. In February 1907 a bulding committee was formed to investigate the advisability of re-modeling or re-building.

The panic of 1907 hindered finances but the building fund grew. The property south of the church was purchased for a parsonage and on April 2, 1911 a new brick building was realized at a cost of approximately \$10,000. It was dedicated on September 30, 1917 and this building serves as the sanctuary of the church today.

Rev. V. E. Patterson was elected pastor March 16, 1913 at a salary of \$680.00 and parsonage. A marked growth in membership was in evidence in 1914 with 247 members reported. Minutes record a revival in November of 1913 in which there were 54 additions, 31 of them by baptism.

July 22, 1914, Rev. O. H. L. Cunningham was unanimously elected pastor. Two names reappear as Clerk of the church through many years of service—Miss Anne Menge and Oscar Haile. Another great ingathering of members was experienced in August 1916 when 66 persons were received. Membership totaled 326 in 1916. The

minutes of January 10, 1917 name at least 30 persons who were "excluded for non-attendance and non-payment of dues." Also two persons were excluded for misconduct. Rev. Cunningham left Farmington in March, 1921 and in April Rev. J. J. Schuler began his work as pastor at a salary of \$1,500 for an indefinite period. He was succeeded in July, 1922 by Rev. G. C. Greenway.

A letter was sent to all members dated July 19, 1922, (copy attached in minutes book), encouraging them to attend and support church financially and to reply as to intent. If member did not respond, name was stricken from the roll. This was a regular practice for a number of years by consent of the church. Membership total was 497 in 1923, making Farmington the second largest church in the Association. (Flat River Membership then 577).

Rev. Greenway resigned October 1926 and Rev. J. W. Jeffries became pastor in 1927. A budget totaling \$6,000 was adopted by the church for 1928, \$2,400 was designated salary and \$2,750 for missions. The first Vacation Bible School was held in 1928 with a daily attendance from 90 to 120. Named faithful in service during the 20's were: J. G. Newman, Chorister, Virginia Morris pianist, E. J. Hunt, Clerk, W. L. Johns Sunday School Supt. and Mrs. Russell Ryan, W.M.U. President.

Brother Jeffries completed his work in September 1929 and Rev. E. H. Zipprodt was elected pastor in January 1930. The following year, Rev. F. Q. Crockett was called following the resignation in March of Rev. Zipprodt. Elbert Menge was ordained to the gospel ministry in June. 1931.

The church celebrated their 50th Anniversary in September 1932. Dr. Edgar Godbold, then Supt. of Missouri Baptist General Association headquartered in Kansas City, was the speaker.

Minutes of July 1934 list Dr. L. M. Stanfield as Financial Secretary and Bob Dugal as Chorister. These men serve in like capacity in the church today. An exceptional revival was held June 1935 when 45 were added to the membership, 32 coming by experience and Baptism. Total membership reported in 1935 was 409. By vote of the church in November 1937 percentage giving for missions was increased to 23% of undesignated gifts. A Hammond Electric organ was purchased in February 1938 and the church adopted the Minister's Retirement plan this year. Rev. Crockett tendered his resignation effective in April 1939.

Rev. W. P. Young of Texarkana Texas accepted the call of the church in May 1939 and remained until 1943. The church then called Rev. R. Ray Stone. Membership was recorded this year at 534, Sunday School Enrollment of 360 and property valued at \$26,000.

### Church of the Month—(Cont.)

On Sept. 25, 1946 the church voted unanimously to start on a new building as soon as possible. This same year the church accepted Brightstone as a mission. The Church became incorporated in 1947. An educational building attached to the back of the auditorium was dedicated on June 5, 1949 with Dr. T. W. Medearis, Executive Secretary of Missouri Baptists bringing the message.

In 1951 a minister of music was employed, Dale Brubraker, who is now Director of Music Dept. for Missouri Baptists. Rev. Stone completed a very successful ten year pastorate in December 1953. The membership had grown to 905 with a Sunday School of 919, Training Union of 224, W.M.U. of 269. The church was also sponsoring two missions, one at Knob Lick and another at Delassus.

The present pastor, Rev. J. Loren Jolly accepted the call of the church extended in February 1954. The past 14 years have been marked by continued progress. The Sunday School growth to 1,005 in 1954 necessitated using the public school building and four houses surrounding the church were purchased and used for Sunday School space until razed to make way for the present educational building which was completed in 1962.

Along with their own extensive building program the church was able also to finance and support building work at Knob Lick Mission and the construction of a new building at Delassus. These missions have now become constituted churches. Growth in Stewardship at the church has been evidenced during these years with mission gifts far surpassing dreams of the early church. Norman Jameson become first educational director employed by the church and Paul Thompson served several years as a minister of Education and at present, Rev. Mel Lantz serves as Associate Pastor. Mrs. Mira Merseal became Church Clerk in October 1946 and has served in this capacity since as well as Church Secretary.

Membership, as recorded in the 1968 minutes, totals 1,002 with Sunday School enrollment of 1,201 and an average attendance of 529. Two morning services have been held for several years and plans are underway to build a new and adequate Santuary to replace the building which has been in use for the past 57 years. Property



On Nov. 5, 1969, you began your eighteenth year.
